## COMMODORE

The first official Board of Governors meeting of 2003 BOG continued the compass direction set by the preceding BOG. The course set was to incorporate the recommendations from the 2002 Commodore special committees. BOG actions included approval for a membership vote on a by-laws change for the renewal billing period dates and for a modest dues increase. These motions have been sent to you and are now in the midst of the 60-day membership review and approval cycle. I would call your attention to the August issue of *The Clew* and the article entitled "SMSA ASSESSMENT". In this article one plan for solving the year to year deficit was outlined. In paragraph seven, an estimated dollar figure was quoted. Rather than make an assessment, a majority of the 2003 BOG voted to present to the membership a motion to increase dues to cover our estimated short fall. If the modest dues increase is approved, we may have the opportunity to end the use of next years funds to pay for last years expenses. Now SMSA membership has the opportunity to review the 2003 Board of Governors recommendations in the form of the motions before you and provide steering commands. I ask for your approval.

We will count the ballots and provide the membership with a draft budget at the General meeting on January 12, 2003.

In the near future, we plan on making a final budget for SMSA after the results of the referendum are known. We will complete those plans in time for the April issue of *The Clew* and before the Opening Day ceremonies.

The motions presented to the membership for approval are the partial fulfillment of my plan for SMSA outlined in the August issue of *The CLEW*. They included:

- Effect changes in the SMSA by-laws to provide for efficient management.
- Establish a dues structure to provide for year to year solvency.

I also included:

- Continue the P&PC as a standing committee for advice to the BOG.

I have appointed Past Commodore Jan Buckler to head this committee.

If I may speak for the BOG, we wish all of our members and valued friends a safe and happy Holiday Season. I hope to see many of you at our

SMSA functions and at future Board of Governors meetings.

## SECRETARY

### APPROVED MINUTES BOARD OF GOVERNORS SPECIAL MEETING OCTOBER 3, 2002

#### OFFICERS AND GOVERNORS PRESENT:

Commodore called the meeting to order at 7:40 p.m.

**Opening Remarks** – The Commodore opened the special meeting encouraging each BOG member to form a group of volunteers to help within their own

new governorship. This may encourage the volunteers to be more involved in the BOG and make them interested in running for a future governor position. He also mentioned that the Vice Commodore would be going over the SMSA 2003 Operational Schedule. The Commodore welcomed on board the two newly elected Membership and Facilities Governors.

**Treasurer** – The Treasurer reported that he and the outgoing Treasurer would meet next Tuesday for their turnover. The outgoing Treasurer reported that he sent out a “well done” to all the BOG members. Last years BOG borrowed a large sum of money and this years BOG will only need to borrow half that amount of money. SMSA has paid \$8,000 in taxes for taxes covering 1999, 2000, and 2001. At this time we do not know what the penalty fees and late filing fees will cost SMSA. He also said he is working on an impact statement of SMSA staying a non-profit vs. profit organization. Last year we were over the 35% allowed for non-member income under the non-profit organization.

**Vice Commodore** – Facilities Governor approached the BOG with a request to use our clubhouse on November 10 for a Junior Varsity Regatta led by Stovy Brown. Discussion followed regarding possible conflicts with LCYC. A decision was made that we need to look at the LCYC schedule and Laura Comeau took this for action.

*Motion:* Approve the Junior Varsity Regatta, with Stovy Brown as event chairman, to use our facility on November 10 barring any conflict with the LCYC schedule.

*Discussion:* Discussion followed regarding insurance, liability for using our boats, etc.

*Result:* The motion was voted on and passed. The Mill Creek Condo Meeting is scheduled to be held at our clubhouse on November 9. The LCYC Christmas Party will be held on the same day as the parade of lights. SMSA’s Christmas Gathering will be on December 14. The January 2003 BOG meeting will be held on January 9 versus January 2.

**Rear Commodore** – The Rear Commodore had nothing to report at this time.

**Membership** – The Membership Governor asked if membership fees could be prorated through the year. Discussion followed and a decision was made that they could be prorated. This decision will be annotated in the BOG Book.

**Social** – The Social Governor asked that anyone planning to attend the Annual Planning Meeting on November 2 to please bring a side dish for the brunch. She also reported that in the past the keys to the pantry have been made available to anyone needing access to the pantry. A change is now in affect so anyone needing the key will need to get in touch with the Social Governor or the Facilities Governor.

**Publicity** – The Publicity Governor was not in attendance.

**Facilities** – The Facilities Governor reported that he has fixed the light on the front porch of the clubhouse. He also asked that perishables be removed from the refrigerator in a timely manner and that all alcohol will be locked up. The combination for the clubhouse will be changed soon.

**Race** – The Race Governor reported that he would be moving the start area for the Frostbite Races. He also plans to change the scoring and points for the Wednesday Night Races. In the Fall Series, the small boats will be separated from the big boats-- there will be one day for each class to race and a day for a crossover race. He is also thinking of relocating the Smith Point Race. Discussion followed regarding his plans to enhance the race schedule and get more racers together.

**Cruise** – The Cruise Governor reported he has several revolutionary ideas for the upcoming season. He is looking into changing cruise points and different ways to earn cruise points. The changes will be up to the cruise leader to decide if it is suitable for their particular cruise.

**Junior** – The Junior Governor was not in attendance.

**Women’s** - The Women’s Governor reported that she is putting an article in *The Clew* detailing all her committee’s planned seminars and events. All seminars will be for members only and will be free of charge unless there is a fee for a speaker.

## **New Business**

### **- Calendar Changes Summary**

The Vice Commodore and the BOG reviewed the SMSA 2003 Operational Schedule. The BOG discussed the schedule month by month and made several changes and additions. The schedule will be reviewed again at the November 2 planning meeting.

### **- 2003 Budget Development**

After the November 2 planning meeting, the 2003 budget will be developed. The BOG will use the 2003 Operational Schedule calendar to project their activities for the next year.

### **Commodore's Closing Remarks**

We have a mission—that is to run SMSA. We can pick a section to focus on and decide where we want to focus our energy (e.g., cruising, racing, parties, etc.). I charge each one of the BOG members to think about what they want to focus on and develop some goals.

## **TREASURER**

As I contemplate writing my treasurer's message I am watching *Stars & Stripes* dueling it out with *GBR* in 17 knots of wind. It reminds once again what this is all about. The love of sailing is the glue that bonds all of us together in SMSA. But, finances are the "hydraulic fluid" that enables our club to operate.

I want to thank all of you for the trust that you have placed in me as your new treasurer. Although I have been a member of SMSA for almost 25 years, this is my first opportunity to serve on the BOG and I am looking forward to it immensely!

I received a good turnover from David Arbuthnot, and the 2002 BOG left us in good shape with the 2002 budget. As we approach the end of the fiscal year (coincidentally the calendar year), it looks like our income for 2002 will cover the year's expenses, resulting in a balanced budget for 2002. That's the good news.

The other news, however, is the continued carry-over of past years' deficits that David and others have written about in recent issues of *The Clew*. Unfortunately, we will once again carry over this accumulated deficit of approximately \$6,000 that was built up over previous years... spending that was over and above income (and/or income that was less than budgeted). Or, in other words, as we close out this year's books, we'll need to "borrow" \$6,000 from next year's dues to pay off the rest of this year's expenses.

This carry-over of prior years' accumulated deficits is an issue that our new BOG is committed to resolving. Thusly, you have recently received a ballot proposal for a by-laws change for a modest annual dues increase. I urge you to approve the increase, as it, along with the 10% increase approved in September, will put us in a position to retire the carry-over deficit over the next couple of years.

At this next BOG meeting we will develop the rough operating budget for next year. But until we know the precise figures for dues income, we won't be able to finalize the budget. This is the reason for the other by-laws change proposal. By changing the dates for dues payments to January 15 –February 15, we will be able to adjust planned expenses, with known income, early enough in the year to effect a balanced final budget.

The other issue that you all have heard about from David is our 501(c)(7) tax-exempt status and the

challenges with respect to taxes on income from non-members (mostly Screwpile money). That challenge is one that we, the 2003 BOG, will continue to pursue, with the goal of resolution to the best possible outcome for SMSA. I am pleased to say that David Arbuthnot, John Weir, Max Munger, and Stovey Brown have graciously accepted the invitation to serve with me on the newly established Treasury Committee, and we will have their combined talent, experience and intellect to assist with these challenges.

Thank you again for the opportunity to serve as this year's SMSA treasurer. I'm looking forward to the challenges and to a great (fiscal) year... and, of course, also to a great year of sailing!

## THE RACER'S EDGE

It is a warm but breezy fall afternoon for a recent "Frostbiter" race and you, as the fearless skipper of *Pedal to the Metal*, are enjoying this late in the season race. As you approach the first weather mark you are on port tack and are enjoying a good breeze. As you approach the starboard tack lay line, you notice your arch rival, that scumbag Poulet Poop skippering his *Wee Willie*, approaching on starboard tack and seemingly moving rather slowly. You decide, using your considerable relative bearing skills, that you can safely pass ahead of *Wee Willie* while maintaining your port tack, so you tell your crew to grin and bear it and help you charge onward to cross ahead of *Wee Willie*. You charge ahead on port tack, hear Poulet Poop shout, "STARBOARD," but keep going confident that you can safely cross ahead. Unfortunately for you, you get a sudden rather large header and you now are in danger of collision! Just seconds before a collision, and nearly deafened by the shouting from *Wee Willie* about STARBOARD rights (and your ancestry), you quickly tack to starboard and limp away from the scene on starboard tack as *Wee Willie*, who had to severely alter course to weather to avoid a collision, now grinds over you to weather about a half boat length away.

Of course you hear Poulet Poop shout, "Protest", and you silently acknowledge that you indeed did screw up a starboard tack boat (but it was of course the wind's fault). You decide to follow the "720 turns" rule in order to vindicate yourself. Having recently seen a Louis Vuitton Cup race televised on the Outdoor Life Network on cable TV, you are now a little confused about when to do the 720 because the Louis Vuitton Cup boats do their 360 turn at their convenience if they acknowledge a foul! You hesitate a few minutes, and then decide that the Racing Rules of Sailing require you to do your 720 immediately. So you inform your crew, do your 720 turn, and sail onward never to catch up with *Wee Willie* who sails on to glorious victory.

After returning to the dock, you discover that Poulet Poop has also protested you for failure to comply with rule 44.2, "720° Turns Penalty" which requires you to "as soon as possible ... to promptly make two complete 360° turns". You notify the race committee that you indeed sailed onward for several minutes before turning ... so you reluctantly accept a DNF from the race committee. Curses... foiled again by the scumbag technocrat rule spouting Poulet Poop.

Note: the alert TV viewer of the Louis Vuitton Cup races now going on in New Zealand will notice that this important series of races does indeed have some "unusual" changes to our racing rules ... so watch the series, enjoy the racing, try to observe these sometimes subtle rule differences, but don't let them interfere with your racing!

### Judge's Response

The Race Committee in the December Racer's Edge acted improperly by scoring *Wee Willie* DNF for two reasons.

First, it is presumed from the facts given that *Wee Willie* crossed the finish line from the direction of the last mark and was not required to correct an error made at the finishing line under rules 31.2, 44.2 or 28.1. The RC was required to give *Wee Willie* the place where they finished (see the Definition of Finish).

Second, the RC had no authority to score *Wee Willie* in any other place than that where she finished (see rule A5). The fact that *Wee Willie* told the RC that she waited several minutes after she broke a rule to take the penalty turns is not a condition under rule A5 where the RC "may take other scoring actions that worsen a boat's score". Only the protest committee has such authority. If rule 44.3, the scoring penalty, had been in effect, then the RC would have had the authority to adjust *Wee Willie's* score. However, rule 44.2 was in effect.

The correct scenario in this case would be for *Wee Willie* to retire under the basic principle of sportsmanship rule on page 2 of the RRS. The proper score would then be RAF (retired after finishing).

If *Wee Willie* thought she did the penalty turns in time, then the protest committee should hear Poulet Poop's protest and (based on the facts presented) DSQ *Wee Willie* for breaking rules 10, 44.1 and 44.2. The RC can then score *Wee Willie* DSQ at the direction of the protest committee.
