## COMMODORE

meeting, we interpreted the tie as leaving the Facilities Governor position vacant (thanks, John Walker). With two vacancies in the 2003 BOG and with nine members of the 2003 BOG present, we appointed Carl Feusahrens as the Facilities Governor and Jay Hanks as the Membership Governor. Welcome Carl and Jay to the 2003 BOG!

I would like you to consider these thoughts. SMSA is a volunteer organization bound together with the love of activities on the water and our many friendships. Let us always put a positive spin on our discussions and dialogues with each other and look for the best in every situation. In this manner, we can strengthen our organization and ourselves and continue to make SMSA one of the leading sailing organizations on the Chesapeake Bay.

My door is always open for comments and discussion. I will endeavor to answer all emails and telephone calls. This is your organization; please do not hesitate to share your ideas with me or with other members of the BOG.

### APPROVED MINUTES BOARD OF GOVERNORS MEETING OCTOBER 3, 2002

The Vice Commodore called the meeting to order at 7:43 p.m.

**Secretary** – The Secretary reported that the e-vote process of the minutes is working fine.

**Treasurer** – The Treasurer reported that the 2001 taxes have been paid. The SMSA 2002 Budget Progress Report for 01/01/02 through 10/03/02 was distributed. Several questions were raised regarding the report, which were answered and discussed. The Treasurer also reported that there were no significant changes from the last meeting.

**Vice Commodore** – The Vice Commodore had nothing to report.

**Race** – The Race Governor made a motion to ask L. G. Raley to run the 2003 Screwpile Regatta. The motion was voted on and passed.

**Cruise** – The Cruise Governor reported they continue to cruise along. A great time was had by all on the one-week cruise to Baltimore. He asks that everyone check *The Clew* for the remainder of this year's cruises.

**Junior** – The Junior Governor was not in attendance.

**Women's** – The Women's Governor reminded everyone that the Women's Cruise is scheduled for this weekend.

**Rear Commodore** – The Rear Commodore had nothing to report.

**Membership** – The Membership Governor reported she has 6 Junior Membership Applications sponsored by Stovy Brown to be voted on. The names of the applicants are: Taylor Woodburn, Adam Sanders, Michael Greenwell, James Baker, Jacob Hall and Kaitlyn Likas.

*Motion by the Membership Governor* was made to approve all 6 applications.

*Results:* The motion was voted on and passed.

*Motion by the Membership Governor* was made to approve the Application for Membership form #1.

*Results:* The motion was voted on and passed.

**Social** – The Social Governor reminded everyone of the Chili/Oyster Scald rendezvous scheduled for October 20 following the Fall Invitational Race. She is also having a brunch following the November planning meeting on November 2.

**Publicity** – The Publicity Governor reported there is an article on Screwpile 2002 in the October issue of *Sailing Magazine*. It includes the SMSA and Screwpile website addresses, and hopefully this will have a positive effect on membership inquiries and Screwpile participation.

**Facilities** – The Rear Commodore reported that the combination to the clubhouse needs to be changed. The combination change will be given to all authorized people. Also the Mill Creek Condo Association will be using our clubhouse on November 9.

#### Old Business

##### - J-29 Regatta

The Vice Commodore reported that plans for a J/29 Regatta on October 26-27 are coming together. Keith Jacobs has volunteered to be the Principal Race Officer. We have at least 2 potential support boats (this is not including the SMSA safety boat). There are 20-30 SMSA volunteers already signed up to help. There are at least five J/29 class members who have volunteered. The class worked with Matt Gambrill to keep as many boats as possible at Calvert Marina. The next regatta

meeting will be Tuesday, October 15 at Nicolletti's.

*Discussion:* The Social Governor reminded the BOG that we have not yet voted on the hosting of the J-29 event. She pointed out that early in this BOG's tenure and in the wake of the Albacore Nationals, THIS BOG instituted a policy stating that all regattas to be hosted by SMSA must receive BOG approval. Prior to the BOG's consideration and vote, a Principal Race Officer (PRO) must be identified and a general plan for the regatta must be presented. The Social Governor believes that the BOG's consideration and vote at this late point in time, a mere three weeks before the regatta, is being treated more of a formality instead of a procedure established as a BOG safeguard to ensure that SMSA does not host sub-par events.

*Motion:* A motion was made to hold the J-29 Regatta on October 26-27.

*Result:* The motion was seconded and approved by voice vote with 9 ayes, 1 against and 1 abstain.

**- BOG Book Final Review**

The Cruise Governor reported that there are a couple items missing from the appendices. He commended Laura Comeau for formatting the document. He has decided to accept the document the way it is and will make it available for the incoming BOG.

## SMALL BOAT

### 6<sup>th</sup> Annual Small Boat Invitational September 21-22, 2002

The 6<sup>th</sup> Annual Small Boat Invitational recently concluded over a beautiful, breezy, late September weekend. Thirty-five boats, ranging from Chesapeake, VA, to Havre de Grace, MD, to Westlake, OH, made the journey to Solomons, MD, to take advantage of the superb racing conditions on the Patuxent River. Mother Nature did not disappoint, as racers were treated to steady breezes ranging between 6-11 knots, occasionally gusting to 15 knots, under warm, sunny skies. SMSA sailors acquitted themselves well over the course of the two-day event.

The Lightning class dominated the event, sending 15 boats to the starting line. The excitement of one-design racing was present from the first race on Saturday through the last race on Sunday. Crowded starting lines, tight mark roundings, and close finishes epitomized the two-day regatta. When it was over, Don Behrens skippered himself to a fifth place finish while Dave Meiser finished ninth in the highly competitive class. It is interesting to note that only 7 points separated second place from eighth place.

The Interlake fleet displayed some of the closest finishes throughout the regatta. John and Barbara Herbig sailed *Gingerbread Man* to a respectable fourth place finish.

The Mobjack fleet had a little last minute juggling to match up sailors and boats. In the end, Joe Kubinec put forward a dominating effort to win the class. What more can be said of a performance in which his throw-out race was a first place finish?

The Portsmouth fleet saw tight racing all weekend, but in the end, it was Clarke McKinney sailing his Laser to victory (via tiebreaker) over Smitty Smith and his Front Runner. Tom Moulds, sailing another Laser, gave SMSA a clean sweep of the top three positions within this class.

Within the Multi-hull class, Jeff and Donna Moore, aboard their Hobie 16, took second place, just missing first place through a tiebreaker.

### SMALL BOAT PROGRAM 2002 SEASON CONCLUDES

The Small Boat Program has now reached the end of the 2002 season. It's just about time to button-up the boats for the winter, plan the off-season projects, and begin thinking about the Christmas wish list. From my perspective, as the Coordinator, it was a very good year. Participation in the Thursday night races remained high while the 6<sup>th</sup> Annual Invitational drew 35 boats. Race committee volunteers quickly filled all open dates and their efforts were smooth and well executed.

Here are some interesting facts from the year gone by:

#### Participation

- There were 18 weeks in the season -3 weeks were cancelled due to severe weather; 1 week was abandoned due to lack of wind.
- Attendance -Nobody had perfect attendance, however, Don Behrens made it out 14 weeks.

- John and Barbara Herbig and Jeff Kumke made it out 13 weeks.
- Dave and Jacki Meiser made it out 11 weeks.
- There were at least 38 different skippers/boats combinations.

### Racing

- There were as few as 4 and as many as 19 (twice) racers on any given evening.
- Wind speed ranged between a low of 1 knot and a high of 14 knots; the average is approximately 7 knots.
- There were 79 starts - As few as 1 and as many as 3 classes starting on any given evening.
- Race Committee recorded 503 race results - There were 21 different types of boats racing on the river.
- Race Committee - Tim Flaherty volunteered for RC on 3 occasions. Thea Noll volunteered for RC on 2 occasions. There were at least 5 "regulars" who volunteered on RC, but did not race this year - Carol Smith, Sam Smith, Denise Kleber, Bridget McNamara, and Dave Pedersen.
- Race Committee was pulled over by Maryland DNR 1 time (because the racers were still on the water at dusk)
- There have been 0 protests filed – ever.

The success of the 2002 season is directly attributed to too many people to mention in this small space. Of course, there were the racers and their crews who came out each week. It was great to see the Junior Program periodically bring the FJ's around from the harbor. The Wharf provided great facilities and food/beverage specials each Thursday night. Of course, none of the racing would be possible if it were not for the selfless efforts of the RC volunteers. I owe you a big THANK YOU for making my job easier and the racers THANK YOU for letting them enjoy a season of sunsets on the Patuxent River.

I look forward to seeing everyone back on the water in Spring 2003.

The double dates for the last cruise of the season are for both the Potomac Sailors and the Solomons Sailors, as the Bay could be very choppy, wet and cold in November. These locations provide for a local destination on either the Potomac or the Patuxent Rivers. Wear your snuggies and come out and join us, as we hope to have a great list of boats in these final cruise articles!

On the subject of cruise points earned this season, I have again filled in, to the best of my knowledge, the cruise point matrix as of October 15. I ask that all cruise leaders and cruisers who have sailed in the 2002 cruising program check for the listing of their boats' participation in the various cruises and assure that the dates and points awarded are indeed correct. I also ask that the long distance cruisers contact me in the next few weeks so that I can

prepare the inputs for the 1,000 Mile Award Plaques. I have five inputs as of October 15. The updated cruise point matrix is included in this issue.

If there are any additional qualifiers for the 1,000-mile Cruiser Award for 2002, please notify me. Currently, *Brigadoon*, *Easytime*, *Magic Oenghus*, and *Serenity* are qualified.

As I conclude my tenure as the 2002 Cruise Governor, I want to thank all the cruise leaders and cruisers that have participated in the 2002 cruising program and made it the success that it has been. I am handing the tiller over to John Walker to begin another lively cruising season in 2003. Please support him as you have supported me for the last two years.

Saturday was a bright sunny day with winds out of the south at 10-12 knots. As Sharpes Island became visible, so did 200 or so little white dots. As we got closer it was apparent we were looking at racers going into the Choptank. *Cat Morgan* (Nikki and Jack Goodman), who passed behind us at N10, was participating in the NASS (Saturday) and in the 42<sup>nd</sup> Annual Hammond Memorial (Sunday) ending at the Tred Avon. This particular race is known for its breakfast punch and I have it on good authority that "punch" doesn't begin to describe it. *Cat Morgan* placed 3<sup>rd</sup> in their multihull class. Arriving at Dunn Cove we discovered an established raft with other boats anchored nearby, including: *Brigadoon* (Janet and Walt Rupp), *Calypso* (Rita and Frank Gerred), *Easy Time* (Suzie and Ron Williams and Tipper), (*Easy Time* will be heading south for the winter),

*Gusto* (Lynn and John Walker), *Mayflower* (Anna and Paul Grisso), *Njord* (Elaine and Jay Green), *Patriot* (Mary and Jay Hanks), *Quintet* (Lois and Gene Norris), *Rigel* (Marc DeLaVergne and guest Cheri Norris), *Serenity* (Dottie and Curt Hamilton and grandchildren Lauren and William), *Swan* (Ellie and Ken Mowbray), and *Morning Star* (Terri and Rick Farman). Happy Hour was in progress on the Gerreds' new 37-foot Jeaneau, *Calypso*. Awesome boat -- Rita and Frank were beaming with pride.

Sunday brought us another beautiful day with winds again out of the south at 10-12 knots. As we came into Sillery Bay on the Magothy River we found *Brigadoon* anchored behind Dobbins Island. At Happy Hour, Ken Mowbray brought a copy of his new book *Chance the Tide* for everyone to see. The book discusses Ellie and Ken's trip down the ICW from the standpoint of what they didn't know and what they did differently the second time around. (The book will be on sale at the boat show with Ken personally signing copies and again at our planning meeting November 2.)

Later in the afternoon *Lynn Dee* (Marilyn and Jerry Eastwood), and *Cat Morgan* (Nikki and Jack Goodman) arrived. In the evening we were rewarded by a beautiful moonrise sparkling over the river. By early morning we were rewarded with a big wind shift to the north – nobody dragged! Monday saw winds out of the north gusting to 20. Everyone elected to stay at Dobbins Island. Many of us explored the area by dinghy. *Cat Morgan* hosted a Happy Hour.

Tuesday we departed at 0700 with winds 8-10 knots out of the north. Baltimore Inner Harbor was our destination. Bill and I took time to swing by the red, white and blue buoy just inside the Route 695 bridge over the Patapsco River. For those of you who don't know, this buoy marks the position of the ship that held Francis Scott Key prisoner and is also where he composed the Star Spangled Banner. *Serenity* rejoined us after returning the grandchildren to their parents. *Mayflower* also rejoined us, along with *Iron Thunder* with Kendra

Palmer and Ed. Happy Hour was held on the dock with everyone going his or her separate way later. We did discuss a change of schedule for Thursday, as the weather was looking particularly threatening thanks to tropical storm Isadore.

Wednesday, *Gusto* and *Mayflower* decided to head home. *Swan* decided to spend a few days on the Wye River and join us St Michaels. Bill and I enjoyed the Pacific Seahorse exhibit at the Baltimore Aquarium. The kelp seahorses were fascinating. Other popular destinations included the B&O Railroad museum, the IMAX theatre, and the local ice cream parlors.

Thursday, we all left the Inner Harbor with destinations of Annapolis and the Rhode River. Winds were out of the northeast at 12-15 knots gusting to 20. We had a fantastic reach down the bay at 7.5 knots with only a jenny. With the threatening weather, most wanted to be on the western shores and closer to home. *Iron Thunder* went all the way home to Chesapeake Beach and *Cat Morgan* went to Annapolis. The rest of us arrived at the cove near High Island on the Rhode River in late afternoon in a steady rain. At Happy Hour we celebrated Walt Rupp's birthday with a delicious cake baked by Janet.

Friday, we lay at anchor awaiting the predicted severe thunderstorms with possible tornadoes. It was the only time I can remember pulling out the reserve anchor and having it ready just in case. *Lynn Dee* elected to go into Galesville and take a slip. Happy Hour was held on *Deshandera*, much to Bill and Charlotte's surprise. Everyone decided, since we didn't have a dinghy, that they would come to us. The bad weather never really materialized, at least in our well-protected anchorage.

## THE RACER'S EDGE

Several SMSA members have commented to me that Poulet Poop, the technocrat skipper of *Wee Willie*, always wins his protests. Some have even suggested that I allow YOU, as the fearless skipper of *Petal to the Metal*, to at least periodically win a protest. So in the interest of fairness and balance, read on.

It's one of the last Wednesday night races of the season, and the good breeze from the West and the course selected by the Race Committee require the racing fleet to finish the race from the East side of the finish line, thus all racing boats must beat to the finish line. After a long hard race, you and your intrepid crew aboard *Petal to the Metal* are still in the hunt, and are in a boat for boat race with your archrival, *Wee Willie*. Both of you are approaching the finish line on a starboard tack beat, (and thus heading directly for the committee boat at anchor at the starboard end of the finish line). Since you are to leeward, but slightly ahead of *Wee Willie*, you are the right of way boat. You continue to charge toward the finish line hoping to keep your bow just ahead of *Wee Willie*.

However, Poulet Poop, aboard *Wee Willie*, seems to be getting a better wind from his position just above you, so he grinds away at your small lead and may even drive over you to finish ahead. You check to be sure that you can clear the race committee boat (as it is bad form to collide with the committee boat). You decide you can clear, and then decide to luff up into the wind at the finish line in order to inch your bow forward to cross the line just ahead of *Wee Willie*. As you and *Wee Willie* close on the finish line, you luff up, shout, "coming up", to *Wee Willie* who responds immediately by also luffing up toward the committee boat. You edge your bow ahead and get the finish gun just ahead of that scumbag Poulet Poop! Victory at last for you and *Petal to the Metal*.
