


OFFICERS AND GOVERNORS PRESENT-Jan Buckler, Bill Moessner, Char Frost, Paul Eubank, Barbara Miller, Tracy Kubinec, and Jim Young.

The meeting was called to order at 6:15 PM.

Secretary- The vote on the minutes for the July meeting will take place at the next meeting.

Membership- Char Frost presented the following applications for new members:

Mark and Diane Gyorgy, family membership, have a Tartan 27 called "Wicked Good", sponsored by Larry Higgins.

Keith Jacobs, who crews on Jammin', sponsored by David Butler.

Both membership applications were approved by the BOG. Welcome aboard!

The meeting was adjourned at 6:20 PM.

The next meeting of the BOG is on September 12, 2000 at 7:30 PM at the SMSA clubhouse. All members are invited to attend.

DRAFT MINUTES SMSA SPECIAL MEETING AUGUST 8, 2000

OFFICER AND GOVERNORS PRESENT: Jan Buckler, Bill Moessner, Paul Eubank, Jim Young, Char Frost, Barbara Miller, Tracy Kubinec, John and Barbara Herbig.

Members Present- A list was started and passed around to note the names of all those present. I do not have the list now. There were perhaps 50 to 60 members present at this meeting.

The meeting was called to order at 6:40 PM.

Jay Hanks of the Policy and Planning Committee presented a list of concerns he has regarding the Southern Maryland Sailing Foundation, the high school sailing program, the SMSA junior program, SMSA training programs, and the use of the SMSA clubhouse.

Mr. Hanks raised questions about the increased liability and usage of SMSA assets to support these programs related to the benefits they will provide to the general membership.

"None of this relates to the basic objectives of the SMSA, which are big and small boat racing, cruising and socializing, or to the secondary objectives which always have included junior programs, small boat racing and free educational seminars. It swings the SMSA resources to a third level objective, which is to promote (not provide) sailing to the public. The one commonality is the junior program, which is up and well with our

SMSA Optimists, etc., with no help needed from outside."

" I see very heavy, undefined and unlimited commitments of our clubhouse and waterfront, our dollars and our people to activities that we do not control and with liabilities not only in dollars but in the good name of the SMSA when something goes bad or simply dies as the instigators move on."

Jim Young and John Herbig explained that the junior program uses the clubhouse for two summer sailing camps and the Sunday junior program. The majority of the children in these programs are members' children, with a minority coming from the community. Many families often become members after their kids get involved in the junior programs. The number of students is limited by the number of boats available, as well as the type of boats SMSA has to offer. The junior program would like to have the use of 420's so that older, bigger kids could participate in boats appropriate to their size and skills.

Stovy Brown spoke on behalf of the SMSF. He was approached by people who wanted to donate boats or money to support high school sailing, the junior program, and the Coast Guard Auxiliary. There is a need for boats for older juniors. Sailing clubs routinely let high school teams use their junior program boats and facilities. The Coast Guard Auxiliary teaches basic sailing but offers no on the water training. There were enough people asking for training to support a training program. The training fees paid help support SMSA. Trained people become dues paying members. These programs provide many benefits to SMSA.

SMSA will have no liability for SMSF assets. SMSA will have no responsibility for storage, maintenance or insurance. SMSA has complete control over its relationship with SMSF through grant requests. SMSA will only ask for what it wants and will get no more than what it asks for. The SMSF can impose nothing on SMSA.

John Herbig addressed Jay Hanks' concerns about the "Herbig Sailing School" by saying that no such enterprise exists. There are no training classes held at the SMSA clubhouse. In answer to questions about costs, insurance and certification of instructors, John replied that he makes no money from the classes, that fees pay for materials used, that SMSA has insurance for training purposes and that there is no requirement for instructors to be certified. A "sailing resume" is used instead. Individual boat owners' insurance covers instructors and trainees when their boats are used for the on-the-water portion of the training.

Jim Young discussed the use of the SMSA facilities by the junior and small boat programs. Children in the junior program are supervised by the instructor, an assistant and many parents. No problems have been reported regarding the library, kitchen or grounds caused by junior program participants. The waterfront and boat hoist are not SMSA assets; they belong to Calvert Marina and are used with permission.

Jim Young listed the current assets of the junior program, which includes the Opti's, the safety boat and various boats occasionally volunteered by other members, such as 420's and lasers. It was suggested that St. Mary's College boats and facilities could be used for the summer camp. SMSF boats could be made available for the junior program as well. The current challenges facing the junior program are

- 1. A place to store the safety boat is needed.
- 2. There is no water down at the beach area
- 3. The Opti's are too small for 13 to 18 year old juniors.
- 4. Mid size boats are needed for older juniors, such as Bytes, Lasers, FJ's or 420's.

It was suggested that parents of junior members can buy these boats for their own children after they outgrow Opti's. Jay Hanks presented a draft SMSA/SMSF Agreement to define the relationship between the two entities.

Jay Hanks led a discussion addressing the proposed changes to the by-laws.

- 1. The purpose of combining the Junior and Women's Governor positions is to have one person responsible for directing all training activities and insuring continuity by keeping those interested in providing the training involved over the long term.
- 2. The purpose of adding the past Commodore position to the BOG is to assist new BOG members, insure a smooth transition and provide continuity to the BOG.
- 3. The purpose of this proposed change is to avoid conflicts of interest between those who serve on other sailing related entities and SMSA's board in matters such as use of SMSA facilities, scheduling of events, and allocation of resources.
- 4. The purpose of a finance committee is to assist the treasurer in putting together the annual budget and in long range planning.
- 5. No discussion.
- 6. The purpose of this proposed change is to define long term indebtedness and to keep members informed of any plans for taking on financial obligations existing over more than a limited time.
- 7 No discussion.

Commodore Jan Buckler stated her goals as reducing SMSA's liabilities, protecting our assets and increasing the usefulness of what we have for all members. Jan suggests that those interested may approach the three Southern Maryland county commissioners about starting and supporting community sailing programs. This would free up SMSA to take care of its own needs. In answer to questions from members, Jan said that liability and

P and I insurance for the SMSA clubhouse, land and waterfront is about \$4,500 annually. It costs about \$2,500 to insure 10 Opti's. In answer to a question about the costs of the training and high school sailing programs, the response is that these programs raised more money than was spent to support them. SMSA is allowed by the IRS to raise funds to support club activities. At a member's suggestion, the treasurer's report will be published once a year in the Clew.

Jan Buckler asks members to think about the direction they want the SMSA to be headed, what assets we want, and what we want to support. Send any questions, comments or issues to Jan that you would like discussed at the annual meeting. Jan would like to see us bridge the traditions of the past with the needs of the future.

The meeting was adjourned at 9:25 PM.

SMSA ALERT

Over the past two years, several new programs and a new organization have been created that have not been approved by the SMSA voters. These include a High School Racing Team Program, a Coast Guard Auxiliary Sailing Program and Basic Sailing Instruction, all using the SMSA Clubhouse and all with on-the-water sessions from the SMSA waterfront, with the Southern Maryland Sailing Foundation [SMSF], a new, non-profit organization, to provide its donated boats, chartered by the SMSA, to support these new activities. Plans include building to 32 boats maintained and operated by the SMSA, as described in SMSF documents. This would require a major shift of SMSA goals and resources, and a very heavy commitment of SMSA volunteers for restoration, storage, maintenance, operation, instruction and supervision. The operations already expose the Clubhouse, library, kitchen, etc., to non-SMSA traffic.

A financial problem is insurance, of boats and people. According to the Charter submitted by the SMSF, for SMSA Commodore's signature, the SMSA will provide full insurance coverage, not only for our uses and people but also for non-SMSA people, and for Foundation uses anywhere, anytime, of the chartered boats.

Note that the only connection between these new activities and the Junior Program, which has functioned well for many years and will continue,

is the proposed chartering of SMSF boats to augment the existing fleet of 10 SMSA, Optimist dinghies. We bought the Optimists. If justified, we could buy larger boats. The Junior Program is doing fine.

Our current Board of Governors [BOG] includes a majority that favors these new actions, with one member also a trustee of the Foundation. Last year there were two -- a conflict of interest, and a potential IRS problem.

The BOG has placed pressure on our Commodore to sign extremely biased Grant and Charter documents that would place the SMSA in a subservient role while authorizing these activities to continue and grow without SMSA member approval.

However, two possible remedies are in progress – Changes to our Articles and By-Laws, to meet the new situation; and an Agreement, to be approved by member vote, that would define the relationship between the SMSA and the SMSF and lead to new Grant and Charter documents. The ballot situation is described below; the Agreement is attached.

A BALLOT HAS BEEN SENT OUT, FOR TALLY AT THE ANNUAL MEETING ON SEPTEMBER 10TH. YOU CAN VOTE AND MAIL, VOTE AT THE MEETING, OR PICK UP YOUR MAILED BALLOT AT THE MEETING AND REVOTE.

The Proposed Changes were developed and recommended by the Policy and Planning Committee [P&PC], and were first approved but then rescinded, by the BOG, for ballot to all voting SMSA members. At this point, some members of the P&PC, with other SMSA members, went the Petition Route to obtain a 60 day procedure, referendum [see Article III, Section 5 of the By-Laws]. Note that the P&PC does recommend passage.

The By-Laws ballot is not a go/stop referendum on these new activities. It is a step toward containing them and keeping the SMSA on its path of 28 years Racing, Cruising, Junior Program, Educational Seminars and Partying, with emphasis on SMSA members but open to guests and joiners.

TO ALLOW THESE NEW PROGRAMS TO CONTINUE AT MODEST LEVELS, WHILE RETAINING THE SMSA THAT WE HAVE KNOWN, AND THAT HAS GROWN TO MORE THAN 350 MEMBERS WHILE DOING OUR THING:

PLEASE VOTE YES FOR ALL OF THE ARTICLES AND BY-LAWS

AND VOTE FOR Jan Buckler, Bill Palmer, Sandy Leitner, Bill Moessner, David Butler, Karen C.R. Moore, Paul Eubank, Walt Rupp, Mary Szczyglowski, and Jay Hanks.

In an attempt to reach a compromise, an AGREEMENT has been crafted, which is attached. During the Annual Meeting, on September 10, 2000, it is expected that a motion will be made to approve this AGREEMENT. This AGREEMENT corrects the subservient problems, places constraints on the new programs, places the SMSA in charge and documents member approval for these new activities to continue. It is believed to be an acceptable compromise.

SMSA and the Southern Maryland Sailing Foundation

A great deal of misunderstanding had resulted from wrong interpretations of the charter and business plan of the new Southern Maryland Sailing Foundation, so at the August 8 Membership Meeting, I was asked to explain the relationship between SMSA and Foundation.

This summary may be of interest to those who could not make it on August 8.

The Foundation was established during 1999 with much consultation with the SMSA Board of Governors and other club leaders to provide a way of bringing in tax-deductible capital funds to sailing programs of the club. The immediate need was double-handed dinghies for a new high school racing program, for older juniors in the club's summer camps and junior competitive events, and for on the water basic sailing training.

The BOG decided that SMSA should maintain its leadership in sailboat racing in the Solomons area by taking on the high school program and offering more advanced racing training for our own juniors. The Foundation concept allowed for these programs to be added to the existing ones with limited capital outlays by the club members (dues or fees). Similar junior programs are offered by other leading clubs, such as Annapolis Yacht Club and Severn Sailing Association.

The Foundation was carefully set up to be non-competitive and fully complementary with SMSA. The Foundation has no programs of its own, but does accept a proposal from SMSA each year for the use of Foundation assets in SMSA-approved programs. The Foundation would then accept this proposal and contract the use of appropriate assets to SMSA. Note that SMSA is fully in charge of this arrangement through its proposal and the contracting process with the Foundation.

The Foundation was set up with a charter broader than SMSA so it could support other youth sailing programs in other organizations in Southern Maryland, should they come forth. This protects the tax-deductible status for gifts to the Foundation in the future. The misunderstandings resulted from a false believe that all the Foundation's support would have to be to SMSA programs. No such intention was ever envisioned.

The high school sailing program has been a great success so far. The Patuxent High School Sailing Club has had about 8 sailors active on 420s at our club on most Thursday and Friday afternoons during the fall and spring semesters during good weather. Last spring, Patuxtent High School awarded seven varsity letters to those who practiced regularly and who represented the school at four regattas where they sailed against other high schools in the middle Atlantic area.

The basic sailing instruction now includes classroom instruction by the local Coast Guard Auxiliary and on the water sessions at SMSA. Last spring, 9 students completed the course and received their Maryland Safe Boating Certificates, required for operating a boat in Maryland if you were born after 1972.

New members to SMSA and numerous crews for weekend and evening racing events have come from both of these programs.

Leaders of the Foundation and SMSA have reached an agreement on the size of the high school program and basic sailing program and some other operational details. These will be explained at the Annual Membership Meeting on September 10. Please come to lend your support for this important agreement.

The following paragraphs and diagram [placed after Race Results in the Clew] are hereby agreed to by

the Commodore of SMSA and the President of SMSF in defining the relationship between the two entities:

PROPOSED AGREEMENT

The activities described (Junior Program, Basic Sailing Courses, and High School Racing) are programs of SMSA and are executed, limited, and controlled by SMSA.

The High School Racing program will be set to a maximum of 15 individuals at this time. Those individuals who have been in this program before will be offered participation for the following season. Additional participants up to the maximum may be accepted. A waiting list of high school students from Calvert and St. Mary's counties will be established. Preference will be given to those on the waiting list when openings occur either in the current or subsequent season. No access to the SMSA clubhouse will be permitted without an adult SMSA member continuously present.

Basic sailing courses offered in conjunction with the Coast Guard Auxiliary will be two a year, once in the spring and once in the fall. Non-SMSA members may participate in these courses. Any additional courses require the proper approvals within SMSA. SMSA in cooperation with the Coast Guard Auxiliary may limit the number of students in the basic courses. The current practical limit is 12 students per class. No access to the SMSA clubhouse will be permitted without an adult SMSA member continuously present.

SMSA will continue to run its summer Junior Program. Non-SMSA members can participate.

SMSA will present the SMSF with a grant proposal that is in line with SMSA's programs and reflective of the above paragraphs. The SMSF will be receptive to such a proposal.

A bareboat charter agreement to be negotiated between SMSA and SMSF will be the instrument under which the SMSF grants usage of boats to SMSA. This agreement will specify that delivery of boats to SMSA and return of boats from SMSA will happen at SMSA. The agreement will specify

that for the duration of the charter, SMSA will have exclusive use of the boats, but may grant usage to other worthwhile organizations at its own choosing and with agreement from SMSF. After a joint survey prior to transfer to SMSA, any major capital repair or replacement items, such as sails, rudders, spars, and hull structure and finish will be accomplished by SMSF prior to acceptance by SMSA.

SMSF is a 501(c)(3) organization that may own boats and property other than those used regularly by SMSA and these will not be SMSA's responsibility in any way. SMSF may grant the usage of these other properties to other organizations in Southern Maryland.

SMSF understands that its charter includes supporting some types of sailing programs that SMSA does not wish to undertake.

These other SMSF boats and properties will not be located at the SMSA waterfront or any other SMSA facility without new negotiations and agreement, and lacking such agreement will not assume any relationship with or require any responsibility on the part of SMSA.

SAILOR TID-BITS

Mishap Report submitted by Jennifer Normyle and the cast of characters from Jammin', David Butler, David Vigeant, Jack Moore, Joy Dorethy, and Keith Jacobs.

It was a beautiful day for a sail yesterday in fact it was a beautiful day for a race. So the
Jammin' crew set out for a Wednesday night race.
We should have known that something was up
when Keith showed up in his Screwpile '96 shorts freshly patched and freshly re-ripped. The fact that
Jack had only flip-flops should have been another
warning. I, with no shoes, should have been a clear
red flag. But no, we raced.

It was a beautiful downwind start. We came in under jib, with the chute at the ready. Butler nailed the start, we launched the chute, but it wouldn't go all the way up. Alas, it was hooked up sideways. Quick thinking and quicker crew work had the jib back up, the spinnaker down, attached correctly, and then re-launched - but not before all the other boats passed us. 
