REAR COMMODORE

As many of you know by now, I am running for Vice Commodore of the club for next year. When Jan first asked me to run for office I told her no, that I would rather wait a year and run for Vice Commodore. When I found out that Barbara was NOT running for Vice Commodore but for Commodore, I e-mailed Jim and asked that my name be placed on the new ballot for Vice Commodore. My qualifications for this office are as follows:

Cruise Governor twice and Rear Commodore twice. In addition I have tried to promote activities that involve the entire membership. This principally takes the form of hosting the

rendezvous at St. Mary's College for the Vice Commodore Cup and club cruise. I buy the drinks and ice and work closely with the Social Governor to see that we have a successful rendezvous. I have also been active with Stovy and Laura in looking for a new club facility after being asked by Jim to do so, and this small committee is well along on this task. Because of recent events, I have also taken an active interest in the P&PC meetings and have attended frequently. I have a strong desire to see that SMSA continues to grow and flourish as a sailing association. To this end I add the following.

At recent BOG meetings David Arbuthnot, as Treasurer, has pointed out that the club is running in the red and we need to increase dues, raise fees and impose special assessments. There has been much contention as to how much to raise these dues, fees, and assessments. I will address raising dues and fees in a later article after I do further research. But I will address assessments now. In order to make up for overspending by past BOG's, and because over the years there have been unexpected expenses not budgeted for, we as members need to assess ourselves and collect money so that the club will be running in the black with a balanced budget as required by the By-Laws. The amount of this assessment is still being

debated, and so far no assessment has been sent out. I suggest that instead of assessing the members we make up any shortages by drawing on the funds in the money market account. There is sufficient money there to cover the shortages and this is what the fund was created for in the first place. There have been those who have suggested that doing so will put in jeopardy our Not For Profit status with the IRS. I do not believe this to be the case after reviewing the IRS publications at

It looks to me as if we can use this money for just about anything we want to. The IRS says, "In general, a club should be supported solely by membership fees, dues, and assessments." It does not say entirely, and in general the shortage could be blamed on unforeseen expenses or shortages due to higher than expected loss of members. If we don't use the money market funds for this sort of thing, then what will we use it for, to buy a clubhouse?

TREASURER'S REPORT

Now that the Annual Meeting has been postponed one week, I will be unable to attend. Much has happened during my tenure as Treasurer that I need to report on and explain:

1. The BOG prepares a balanced budget each year with every intention that it is realistic. To make it easier to identify trends in a timely manner, I have required each board member to prepare their budget on a monthly basis. However, no contingency or extraordinary items are usually included. Each BOG leaves office before the full accounting for their commitments. For various reasons, more

related to lower income than higher expenses, we have habitually run a small deficit at year-end. This deficit is paid by using the following year's income (dues) to pay the last commitments from the previous year. I have recommended to the BOG that we have a one time assessment of 45% to bring us up to date; that is, start 2003 with the previous year's commitments fully paid and with \$2,000 in the bank. This action has been postponed until after the Annual Meeting.

2. Currently, our expenditures for this year are in line with the amounts budgeted but we will probably again have a deficit because income (primarily dues) is less than budgeted. Note that this comes from non-renewals; new memberships are ahead of budget. Also, please note the exceptional performance by our Junior Governor. His programs are expected to break even for the first time in several years, despite fully funding the new safety boat from his budget.
3. Since our income from all sources (except Screwpile – more on that later) is insufficient to cover our programs, I have recommended a dues increase, for the first time in over 10 years, starting in 2003. This dues increase would permit us to continue our current programs at the same level plus provide for limited capital expenditures, which often are not identified at the time the BOG takes over. Provided the family membership is increased to 150% of the individual membership at the Annual Meeting, I recommended an increase of 20% to \$120 for the individual membership. This would provide \$5,000 each year for capital expenditures and \$2,000 cumulatively each year for inflation. None of this dues increase is earmarked for a new clubhouse-building fund. The BOG felt that 10% was sufficient, and that is the number on your ballot. Provided fees and special event contributions are increased significantly, that may be enough.
4. SMSA is incorporated as a 501(c)(7) tax-exempt corporation. This is not to be confused

with any kind of charitable (non profit) tax status, rather the reason social clubs can receive this status is the assumption that they are indirectly through their own dues and fees paying for their benefits. In 1976, the code governing this type of tax exempt corporation was amended to permit up to 35% income from non-members, provided this income did not in any way benefit to the personal advantage of the members, such as reducing dues or fees. For this reason, and in order to protect our tax-exempt status, I have insisted that the money market fund (which currently exists solely because of net profits from the Screwpile Regatta so ably managed by LG Raley) not be used for any operating needs. The balance in the Screwpile money market account (after paying 1999 and 2000 income taxes but before interest and possible late filing penalties) is about \$63,000.

5. If you add up all our non-member income (Screwpile, yearbook advertising, summer camp fees, non-member racing fees, etc.) we come very close to the 35% limitation on non-member income to preserve our tax-exempt status. There are several solutions to this: reduce non-member activities, make those wishing to participate in SMSA programs first become members, increase contributions from members (increase dues and fees). These are issues that need to be addressed by the next Treasurer and BOG. Another possible solution is to give up our tax-exempt status and become a for-profit corporation and then seek to maximize non-member income and pay tax on it. The full ramifications of this have not been explored, but it is clear that the book keeping would then be far more complex and probably require a paid bookkeeper to keep us out of trouble!

POLICY AND PLANNING

The primary subjects for the P&PC this month were the Articles and By-Laws ballot and the dates of the fiscal year. The following comments have been kept short. Please contact me, or any other P&PC Member, for more details.

Motions 1 and 2. The opinions were unanimous that motions 1 and 2 contain conflicting actions, pre-empt the 60-day process, remove flexibility from the Commodore and BOG, unnecessarily replace the small, adequate sub-committee of this BOG, and are premature.

Unanimous Recommendation – vote NO on both.

Motions 6 and 7. The opinions were unanimous that the presentations are confusing and incomplete and a strong consensus was that the dues amounts

are too little to meet our needs and preclude a growing deficit. Our recommendation was a reluctant YES, because the ballot words cannot be changed and some increase is offered. However, in the BOG minutes for August 6, you will read of a later BOG decision to recommend voting NO, assuming that the problems of deficit, assessment and dues will be re-addressed correctly.

Current Recommendation of the BOG and P&PC Chairman -- vote NO on both.

Motions 3, 4, 5 and 8 – vote YES.

Regarding a change of the fiscal year, initial discussion prompted a flurry of emails among BOG and P&PC members, with new thoughts gradually changing opinions. Unfortunately, some BOG members did not participate (too busy or email system down) and the BOG decision, on August 6, did not reflect current thought. I sent an email in advance, and presented a one-page summary of the latest thoughts at the BOG meeting. It was not used. Hopefully, this subject will be discussed at the Annual Meeting.

A strong recommendation from the P&PC is that a review of all programs, regarding costs, incomes, dues, fees and assessments, must be done, leading to decisions regarding the financing of each program, including how much of each program should be supported by normal dues. This should be done by the next P&PC.

Under late breaking news, I was fired by the Commodore, because I would not accept a task for which the P&PC is not qualified and for which the SMSA already has paid \$1,000 for a professional opinion, and have the same opinion, gratis, from my personal CPA. Screwpile money cannot be spent on anything that reduces the current or future dues of individual members. Deficit reduction – No. Clubhouse, boats, equipment – Perhaps. The P&PC could advise regarding a specific proposal, but it would not be a professional opinion. Some of our activities show a profit. Why not file our tax

returns, estimating amounts owed, and then ask the IRS for a reading regarding Screwpile and other money?

THE RACER'S EDGE

A good breeze and light chop characterize the Patuxent as you, skipper of the infamous PEDAL TO THE METAL, are running downwind on a starboard tack and are overlapped and to leeward of your arch rival WEE WILLIE as you approach "V" mark which you both MUST jibe around to pass to port. Prior to passing the mark and barely outside the two-length zone you cleverly decide to luff WEE WILLIE and take her well beyond and above the mark in the hopes of gaining a significant tactical advantage. You drop your spinnaker, and luff WEE WILLIE but immediately get a "Protest!" hail from Poulet Poop, WEE WILLIE's skipper. You go to the protest hearing a little uncertain of your fate, but confident you had some luffing rights. You lose and are disqualified! Why?

Rules 18.2 (a) and 18.4 require you, the inside overlapped boat at a jybing mark, to "sail no farther from the mark than needed to sail the course". This requires you to maintain your course and jibe immediately to pass the mark. Your luff of WEE WILLIE changed your course and delayed your jibe ... thus you are in violation of rule 18.4 and are disqualified.

While the old rules would have allowed a luff beyond the mark (by both boats), the current rules have outlawed this practice in the interest of safety, keeping all the boats racing on course, and just general good sense.

The Judges Respond

This month's Racer's Edge begs an often asked question, just when does an obligation under Rule 18 begin when it is in conflict with another rule?

In this case, before the two boats reach the two-boat length zone, the leeward boat has the right to luff as long as she did not establish her overlap on the windward boat from clear astern. Within the zone, she is considered to be in the process of rounding, and this must comply with RRS 18.4, that is, "sail no further from the mark than needed to sail that course."

When do the leeward boat's rights under RRS 11 (Windward-Leeward) yield to RRS 18.4?

RRS 18.1 states, "Rule 18 applies when boats are about to round or pass a mark..." The term "about to pass" is not defined by the rules, but we can borrow from the definition of "room" for guidance. "Room" is "the space a boat needs in the existing conditions while maneuvering promptly in a seamanlike way." So Rule 18 can be construed to come in effect when, under existing conditions, the boats need to maneuver promptly in a seamanlike way. Certainly at a leeward mark in a good breeze when taking down spinnakers is part of the maneuver, Rule 18 would commence at the two-boat length zone. If the boats are large and traveling very fast, the rule could come in effect at three or more lengths from the mark. In light conditions with a foul tide, Rule 18 may not commence until one length from the mark. But convention is to start Rule 18 at the two-length zone and to place that invocation differently puts a burden on the boat that is claiming the difference to make a good case. Stovy Brown

From Washington D.C. and Northern Virginia:

Take I-95/495 to Route 4 (Pennsylvania Ave) south approximately 45 miles. Once you pass the turn to Lusby Town Center begin to look for Dowell Road on your left. Turn left onto Dowell Road and continue to Calvert Marina. See below for directions in marina.

From Annapolis:

Take Route 2 (Solomons Island Road) south out of Annapolis. Route 2 will merge with Route 4. Once you pass the turn to Lusby Town Center (about 30 miles) begin to look for Dowell Road on your left. Turn left onto Dowell Road and continue to Calvert Marina. See below for directions in marina.

From Points South (Norfolk/Hampton/Fishing Bay):

Take I-67 to I-95 north or Route 17 North. Exit at Route 301 north and cross the Harry W. Nice Bridge into Maryland. Turn right off of 301 onto Route 234.
